The VSC from July 2024 - December 2024

Our office has seen 160 new veterans, processed 539 claims, ment times are between the applied for VA Healthcare Benefits for 77 veterans, provided \$45,391.71 in Emergency Financial Assistance, and we have conducted 449 trips to the Erie and Cleveland VA Medical Centers. Through the efforts of our service officers, so far in 2024 Ashtabula County veterans have seen 1,107 awards totaling \$1,982,591.71 in retroactive lump sum payments and new monthly compensation incomes totaling \$22,836,664.62. This does not include other benefits, such as medical and education cost savings. The members of this office are highly trained and extremely motivated to assist you in obtaining your earned benefits. It doesn't matter if you served in or out of a combat zone, or even during a war time period. Your benefits were earned throughout your service and you owe it to yourself, as well as your family to work to obtain them. Our team is committed to advocate for and assist our veteran community throughout the claims process and throughout their life here in this great county. We encourage all veterans of all ages to reach out to our office and allow us to provide a "Benefits Well-Check." Remember! You have everything to gain and nothing to lose! If we are successful in our advocacy, you could quite literally experience a significant change in your quality of life. Let us be YOUR advocate!

VSC Transportation Program. The VSC provides transportation to the Erie VA Medical Center and the Louis Stokes, Cleveland VA Medical Center on a daily basis. If you need a ride, please arrive to our office no later than 8 a.m. We will verify your eligibility for transportation, provide you with a VSC ID Card (if you don't already have one), manifest you and we leave by 8:15 a.m. daily. If we have veterans that need to go both directions, we activate our volunteer drivers and we go both directions. It's that simple! Eligibility for transportation through our office means that you have a DD214 on file with our office and you are in receipt of VA Healthcare benefits. Please make sure that your appoint-



hours of 9:30 a.m. and 1 p.m. to ensure that we are able to transport you. Our driver must leave either facility no later than 2 p.m. to get back and reset for the next day's travel.



The PACT Act and your VA benefits. The PACT Act is a law that expands VA health care and benefits for Veterans who may have been exposed to burn pits, Agent Orange, and other toxic substances. This law helps provide generations of Veterans-and their survivors-with the care and benefits they've earned and deserve. To be eligible to enroll in VA health care, Veterans must meet the minimum active-duty service requirements, have a gualifying discharge, and meet one or more eligibility requirements specific to VA health care. VA encourages all Veterans to apply to determine their enrollment eligibility.

If you served in the following countries during specific time periods, you can enroll in VA health care:

- Republic of Vietnam between January 9, 1962 and May 7, 1975
- Thailand at any U.S. or Royal Thai base between January 9, 1962 and June 30, 1976
- Laos between December 1, 1965 and September 30, 1969
- Certain provinces in Cambodia between April 16, 1969 and April 30, 1969
- Guam or American Samoa (or their territorial waters) between January 9, 1962 and July 31, 1980
- Johnston Atoll (or a ship that called there) between January 1, 1972 and September 30, 1977

You can enroll in VA health care if any of the following are true:

 You performed active duty while assigned to a duty station (including air space above):

On or after August 2, 1990, in the following countries: Bahrain, Iraq, Kuwait, Oman, Qatar, Saudi Arabia, Somalia, or the United Arab Emirates

On or after September 11, 2001, in the following countries: Afghanistan, Djibouti, Egypt, Jordan, Lebanon, Syria, Yemen, Uzbekistan, or any other country determined relevant by VA. (Note: VA has not determined any other country relevant at this time.)

• You deployed in support of the following contingency operations:

Operation Enduring Freedom, Operation Freedom's Sentinel, Operation Iraqi Freedom, Operation New Dawn, Operation Inherent Resolve, Resolute Support Mission

• You served on active duty in a theater of combat operations or in combat against a hostile force during a period of hostilities after November 11, 1998 and you were discharged or released from active service within the last 10 years


Veterans Who Were Exposed to Toxins and Other Hazards During Service

Regardless of when or where you served, if you were exposed to toxins and other hazards while serving our country, you can enroll in VA health care. Even if you never deployed outside the U.S., you may be eligible. If you may have been exposed to toxins or hazards while on qualifying training or active duty in the United States, you can enroll. Exposure to toxins and other hazards includes air pollutants, chemicals, occupational hazards, radiation, warfare agents, and more.

The PACT Act makes it easier for many survivors to receive Dependency and Indemnity Compensation (DIC). The VA will be contacting survivors who were previously denied DIC benefits and may be newly eligible under the PACT Act. You do not need to wait for VA to contact you to submit a claim. Make your appointment today with a service officer. If your veteran passed away due to illnesses that are presumed to be associated with Agent Orange exposure, you may be eligible for Dependency and Indemnity Compensation. This is a monthly payment for the eligible surviving spouse, dependent children or parent(s) of the Veteran or service member IF the Veteran or service member died in the line of duty or due to a service-related injury or illness. Additional survivor benefits that are available, should you be awarded are burial and burial allowance, education and training, home loan guaranty, and health care.

Care for Caregivers - Did you know that the Veterans Administration has a Caregiver Support Program? This program provides caregivers with the help and resources they need to care for the veteran during a point in their life where they need assistance from another person to impact their quality of life in a positive way. To be eligible for this service, the Veteran must have a service-connected rating through the VA that is at least 70% or higher; <u>and</u> be enrolled in VA healthcare; <u>and</u> require assistance with Activities of Daily Living (ADLs); <u>or</u> need supervision, protection, or instruction for their safety. The caregiver must be 18 years or older; <u>and</u> either be a family member, extended family member, or someone who lives (or will live) with the



eligible veteran. They must be designated as a caregiver, and have completed the caregiver training. As a caregiver, you can get peer support, skills training, respite care, and referrals to available resources. If the VA determines that a veteran is "<u>unable to self-sustain in the community</u>," the caregiver may qualify to receive a monthly stipend.

NOTE: <u>Unable to self-sustain in the community</u> means the veteran requires assistance with activities of daily living such as bathing, feeding, clothing oneself, toileting...etc., or needs supervision or protection due to neurological impairment. For more information, please call Caregiver Support Line 855-260-3274.

VA Grant Programs - Specially Adapted Housing (SAH) Program - The SAH grant is designed to help disabled Veterans by providing a barrier-free living environment, such as a wheelchair accessible home, that affords them a level of independent living they may not otherwise enjoy. Veterans and Service members with specific service- connected disabilities may be entitled to a grant for the purpose of constructing or modifying a home to meet their adaptive needs, up to the current maximum of \$117,014. The SAH grant can be used up to six times and is available to certain Veterans and Service members who are entitled to VA disability compensation due to:

• Loss or loss of use of both lower extremities, such as to preclude locomotion without the aid of braces, crutches, canes, or a wheelchair, or

- Blindness in both eyes having only light perception, or
- Loss or loss of use of one lower extremity together with (1) residuals of organic disease or injury, or (2) the loss or loss of use of one upper extremity, affecting balance or propulsion as to preclude locomotion without the aid of braces, crutches, canes, or a wheelchair or,
- Loss or loss of use of both upper extremities at or above the elbows, or
- A severe burn injury.
- The loss, or loss of use, of one lower extremity (foot or leg) after September 11, 2001, which makes it so you can't balance or walk without the help of braces, crutches, canes, or a wheelchair

Special Housing Adaptation (SHA) Grant - The SHA grant can be used up to six times to increase the mobility of eligible Veteran and Service members throughout their residences. Veterans and Service members with specific service-connected disabilities may be entitled to this type of grant, up to the current maximum of \$23,444. The SHA grant is available to certain Veterans and Service members who are entitled to disability compensation due to:

- The anatomical loss or loss of use of both hands or extremities below the elbow, or
- A severe burn injury.

Temporary Residence Assistance (TRA) Grant - A temporary grant may be available to SAH/SHA eligible Veterans and Service members for one-time use who are or will be temporarily residing in a home owned by a family member. The maximum amount available to adapt a family member's home for the SAH grant is \$47,130 and for the SHA grant is \$8,415.

Home Improvements and Structural Alternations (HISA) Grant - Veterans and Service members may receive assistance for any home improvement necessary for the continuation of treatment or for disability access to the home and essential lavatory and sanitary facilities. A Veteran may receive a HISA grant in conjunction with either a SAH or SHA grant. The HISA program is available for both Veterans with service-connected disabilities and Veterans with non-service-connected disabilities.

- Home improvement benefits up to \$6,800 may be provided to Veterans with service-connected disabilities, and up to \$2,000 may be provided to Veterans with non-serviceconnected disabilities.

Vocational Rehabilitation and Employment (VR&E); Independent Living (IL) Adaptations - VR&E sponsored Independent Living services may be provided to individuals who are not currently able to work because of the effects of service-connected disabilities. Provided services are limited to those required to improve independence at home and in the community and may include home adaptations.

• Home adaptation benefits up to \$93,356 may be provided

to Veterans with service-connected disabilities as part of an approved Independent Living Plan.

For more questions or for assistance applying for one of these grants, make an appointment with one of our service officers!

The Military Injury Relief Fund (MIRF) grants a tax-exempt payment to military service members injured in combat as a member of the Armed Forces of the United States serving after October 7, 2001, and to individuals diagnosed with post-traumatic stress while serving after October 7, 2001. The amount of a MIRF grant is \$500. This benefit used to be a one time payment, but has recently been updated to allow veterans to apply for the benefit one time each fiscal year in Ohio, for up to 3 years total. If you are a surviving spouse or dependent, you can still apply; you will still need to provide all required information with the initial application, including an executor or administrators of the estate of such "eligible individuals," since you'll be applying on behalf of the service member. Allow 6 to 8 weeks for processing. During June and July, delays in processing and delivery can be expected due to the end of the fiscal year. You can get the application and have a service officer assist you in filling it out - come to our office. The MIRF grant is not taxable income, nor is it based on income you currently receive.

A VA Pension Debt Notification has been issued identifying discrepancies in data matching resulting in overpayment's for VA Pension in some cases. These low-income waived debts are typically identified as significant hardship. The VA has recognized the hardship and distress that these pension debts may cause and has paused the collection of all established pension debts and the establishment of new pension debts while they determine the path forward. The VA has stated "reaching out directly to affected Veterans and survivors to let them know that pension debt collection has been paused while we pursue options for relief – and we will keep them updated throughout every step of this process." If there are any immediate concerns or questions the VA encourages those with debt questions to call 1-800-827-0648.

VSC Outreach July through September. On July 28, the VSC co-sponsored the Heroes & Legends Concert with Craig Morgan and the Army Outreach Band, "As You Were." We presented the Blue Star Mothers of American, Geneva Chapter with our sponsorship check of \$5,000.00 to assist them in their mission to support active-duty service members overseas and our veteran community at home.


